

Find and view a notification (for all users)

This quick reference guide takes you through the steps to find and view a notification made to Taumata Arowai relating to one of your drinking water supplies. The notification may have been submitted by a drinking water testing laboratory or by someone related to your supply.

Notifications have three categories:

- Laboratory notification
- Risk to drinking water safety or quantity
- Stop, Limit or Reduce supply or Change Ownership

View the list of notifications related to a supply

Step	What to do
1	When you log in to Hinekōrako you will see a list of your supplies on the <i>My Supplies</i> page. If you are not on the <i>My Supplies</i> page you can go to that page by clicking on <i>My Supplies</i> in the menu at the top of the page.
	Your supplies will be in one of three lists:
	 In Progress Supply Registrations, for all registrations migrated but not yet confirmed or started and not yet finished.
	 Registered Supplies, for all confirmed migrated registrations and submitted new registrations.
	Other Supplies, for registrations with any other status, e.g. deregistered supplies.
	Find the supply for which you wish to view notifications and then from the drop down menu at the end of that supply's row, choose <i>View Supply Details</i> .

2	You will be taken to a screen where the details of the supply are shown. There will be one or more actions you can take in relation to the supply in a list to the left. Click on <i>View/Add Notifications</i> .

Step	What to do
3	You will be taken to a screen where any previously submitted notifications in relation to the supply are listed.
	This includes notifications submitted by yourself or someone else with access to your supply and notifications submitted by a laboratory with test results for a sample from your supply.
	There are two lists:
	• A list of <i>Draft</i> notifications that you or someone with access to your supply has started but not yet submitted.
	• A list of supplier and laboratory notifications that have been submitted to Taumata Arowai.
	You can view a notification from either list. To do so, click on the drop down menu at the end of the row for that notification and choose <i>View Notification</i> .

Step	What to do
4	You will be taken to a screen where you can see all the details of the notification. The details listed for any given notification may differ depending on the options selected in the submission of the notification. For example, if you indicated that the laboratory has already notified Taumata Arowai of non-compliant water, the <i>Notification ID</i> of the laboratory notification will be displayed. Whereas if you provided the laboratory test results yourself, those test results will be displayed.
	Scroll down the screen to see all of the details.
